# Locating Your Roots: Discover Your Ancestors Using Land Records By Patricia Law Hatcher, FASG, FGSP

This book, put out by the Genealogical Publishing Company and updated in 2016, has a wealth of information for those who, like me, are finally (screaming and protesting all the way) turning to land records to break down brick walls.

I've been stuck for years trying to account for the movements of my 2nd-great-grandfather, Reuben, who seems to have disappeared months after his son was born in 1850. Had he died? Had he abandoned his family? Or, had an unhappy wife—found in the next census living with her younger brother—kicked him out? Although the answers to the last two questions won't likely be revealed, documents show Reuben's wife Hannah was married five times, so she was either very unlucky in love, or her spouses were.

I'd mostly searched within my comfort zone—birth, marriage, death, military, newspaper, and census records—until a researcher in Ashtabula County, Ohio, found a quit claim Reuben signed in 1854, which assured me that his marriage wasn't an until-death-do-us-part scenario.

To delve deeper, I'm turning to Discover Your Ancestors Using Land Records, which includes the whys, where's and how's of researching these valuable resources. Although the historical content and in-depth information will satisfy advanced genealogists, the material is easily accessible to those of us just starting to dig into land records. The book is well written, easy to follow and contains lots of examples, as well as a 16-page glossary. Hopefully, Hatcher's advice will help me unearth more about Reuben.

Note: This is the updated 2016 edition which states it "has been reviewed for obsolete references and information, which have been deleted or revised. Some references have been added." It can be purchased from the publisher at genealogical.com. I did not buy my copy from Amazon, which appears to be selling an older edition.

I wish you Happy Summer Reading. I'll have more book reviews for you in the Fall.

Today, the results we seek could be a matter of minutes away, thanks to the many digitization projects that have placed millions of newspaper pages on the Internet. But what are the pitfalls? This presentation takes you through the digitization process, from hard copy to your computer screen. It is designed to help you achieve the best results from your work. (Note: Dave Obee has worked in newspapers for 50 years, has researched with them for 50 years, and has been behind a major digitization project. This talk draws from real experience.)




