
# Check the Original Document – Don't Trust the Index

We often hear that it's very important to look at the original document when possible, and not to rely on the index. I messed up!

My paternal grandfather was an Ashkenazi Jew who immigrated from Europe about 1885. He died in an industrial accident in 1929, so I never met him. Everyone always said he was from "Germany" and German was his first language. (I have the names of his parents from his marriage license, and his brother said that he himself came from Berlin.)

I always wondered where in Europe my grandfather came from but resigned myself to living with this "brick wall" – I needed more information and didn't see any obvious way to get it.

While looking at the 1920 census recently to verify the names and birth dates of my uncles (my father was the youngest of 10!), I noticed something – although the census *index* reported that he claimed to have been born in Germany, the entry itself was "interesting":



The enumerator wrote "Breslow" (which was almost certainly "Breslau" in Silesia, part of the German Empire which became "Wroclaw" in Poland after World War I) and corrected himself and wrote "Germany."

Actually, based on enumerator's instructions for the 1920 census, Breslau or Silesia would have been the correct entry. If a respondent said "Germany" (or any of the other countries where borders moved post WWI) the enumerator was to find out exactly where and list the region or city. (The instruction seems to have required more knowledge of European geography than most enumerators possessed -- for example, he didn't list Alsace-Lorraine for my grandmother, as he should have.)

In any case, I now have additional information I can play with!
