**Myth-Busting Family Lore**

Participants will be presented with clues that can be found on the “right side” of documents and how they can use Google maps to give credence to family lore. There are many family myths, legends or stories that need some substance to prove their validity. Published records of our families’ activities, including ship manifests and census records, may provide some clues to these family stories. Using Google maps and placing markers for found clues, then superimposing an historic map, might provide enough clues to make sense of family lore.
